

RAWHIDE ADVENTURES: Waiver and Liability Release

Please read carefully before signing. This is a release of liability and your waiver of certain legal rights.

In consideration for my being permitted to participate in the activities of RAWHIDE ADVENTURES Inc. and the use of the property, animals and facilities, I agree to the following Waiver and Release:

I acknowledge that horseback riding, hiking, fishing, hunting, tobagganing, skiing or snowshoeing has inherent risks, hazards and dangers for anyone, that can not be eliminated, particularly in a wilderness environment. I understand that these risks, hazards and dangers include without limitation:

1. The propensity of the animal to behave in ways that may result in injury, harm or death to persons on or around them;
2. The unpredictability of the animals reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals;
3. Certain hazards such as surface and sub-surface conditions;
4. Collisions with other animals or objects;
5. The potential of the participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within his or her ability. I may encounter variations in terrain that are my responsibility and I assume these risks including creeks, water, bridges, travelled roads, wild things, stumps, forest growth, debris, rocks and cliffs, and other obstacles, whether they are obvious or not obvious, man-made or natural;
6. Hiking in rugged country;
7. Tobbagening or skiing in rough and ungroomed terrain;
8. Encounters with wildlife, animals and insects;
9. Temperature extremes and or inclement weather conditions;
10. Unavailability of immediate medical attention in the wilderness in case of injury;

I understand the risks, hazards and dangers described above and have had the opportunity to discuss them with RAWHIDE ADVENTURES Inc. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities: I am in good physical health and have the ability to safely engage in equine activities. It is solely my choice to ride with or without a helmet and I have been advised by my trailboss, that wearing a helmet can significantly reduce my risk of serious head injury, but will not protect my neck or back. My participation is purely voluntary. No one is forcing me to participate and I elect to participate in spite of these risks. I also acknowledge that I have not consumed any alcoholic beverages today.

Lastly, I, for myself, my heirs, successors, executors and subrogees, hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS RAWHIDE ADVENTURES INC., their directors, officers, agents, employees, property owners and volunteers from and against any and all claims, actions, liabilities, law suits, expenses (including reasonable attorney fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or in the use of these services, animals or equipment, whether such damage, loss, injury, paralysis, or death results from negligence of Rawhide Adventures Inc. or from some other cause.

I, for myself, my heirs, my successors, executors, and subrogees, further agree not to sue RAWHIDE ADVENTURES Inc. as a result of any injury, paralysis, or death suffered in connection with my use of services and participation in the activities of RAWHIDE ADVENTURES Inc..
